## Academy Rules:

The Trust Board sets rules to ensure that all students are treated fairly, respect each other and their property. Rules may be changed from time to time as the Board sees fit. Given the location of the academy and the frequency of our students in the community, it is important that rules are kept.

**Attendance** – students must attend academy each scheduled day. When there is sickness, or another good reason, the school must be notified as soon as possible on that day. When the student returns to the Academy, a written note is required.

**Inappropriate Items** – the normal items that schools and colleges exclude are not to be brought to The Villa Education Academy (gum, alcohol, cigarettes, inappropriate literature or electronic material).

**Internet Use** - the Internet and e-mail facilities must not be misused in terms of sending or downloading inappropriate materials. All students/parents will be required to sign a standard Cyber safety agreement form.

## Student subject choices:

At The Villa NCEA Academy, students can take six subjects across NCEA Levels 1-3. Core subjects of English and Mathematics are taught by specialist teachers for one period respectively each day.

In addition, generalist teachers will support students to study three or four additional subjects, chosen in consultation between the student and the principal.

<b>Application Fee:</b> (Applies to newly enrolled students, those currently enrolled at MHMS are exempt.)	<b>\$200.00 (non-refundable)</b>
<b>Entrance Fee:</b> (Applies to newly accepted students, those currently enrolled at MHMS are exempt.)	<b>\$500.00 (non-refundable)</b>
<b>Tuition Fees for New Zealand Citizens and permanent residents:</b>	<b>\$15,000 (per year)</b> Fees, as shown below, will be charged four times per year and are payable by the end of the first week of every term. - \$3,750 A discount of 5% is applied where there are two students from the same family. The discount increases to 10% when three or more attend from the same family. Discount applies to the tuition fee only.
<b>Payment options:</b>	<ul style="list-style-type: none"> <li>- A monthly payment option is available.</li> <li>- If the full year's fees are paid at the beginning of Term 1, a \$400 discount per family will be applied.</li> </ul>
<b>Tuition Fee for International Students (please note, these fees apply to all students without permanent residence in New Zealand):</b>	<b>\$23,000 (per year)</b> The annual tuition fee for overseas students must be paid in full by 11 <sup>th</sup> January 2016 to allow adequate time for a student visa to be issued by the New Zealand Immigration Service.
<b>Additional Costs:</b>	Examination fees for entrance into NCEA standards: Domestic students - \$76.70 per year International students - \$383.30 per year. (Please note – these figures are subject to change).
